DISCUSSION:

Each year the Auditor-Controller prepares the annual budgets for the special districts governed by the Board of Supervisors pursuant to California Government Code, Title 3, Division 3, Chapter 1. Government Code Section 29080 requires that on or before September 8 of each year, the proposed budgets and the documentation used to establish the proposed budgets be made available for public inspection at least ten (10) days prior to the public hearing pertaining to such budgets. The Clerk of the Board of Supervisors published notice on or before September 8, 2014, that this documentation is available for inspection at the Office of the Clerk of the Board and that the Board will consider adoption of the proposed budgets on September 23, 2014. The Board of Supervisors, sitting as the Board of Directors of those special districts governed by the Board of Supervisors, will with the adoption of the accompanying resolution comply with all the legal requirements for adoption of a budget for each special district enumerated therein.

FINANCIAL IMPACT:

Government Code, Title 3, Division 3, Chapter 1 requires each special district to adopt a balanced budget on an annual basis. The budgets presented in the resolution meet the legal requirements for fiscal year 2014-2015.

OTHER AGENCY INVOLVEMENT:

Some of the districts with local boards participated in preparation of these budgets.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

While annual adoption of a balanced budget for each district is mandatory, the Board could choose to have staff modify the attached budgets if it deems necessary.
