GOVERNING BODY RESOLUTION FOR DIRECT RELIEF SEARCH AND RESCUE FUND GRANT

WHEREAS, the Humboldt County Sheriff's Office desires to participate in the Search and Rescue Fund grant opportunity administered by Direct Relief.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt Board of Supervisors hereby:

1. Approves receiving grant funding from Direct Relief.
2. Authorizes the County Administrative Officer, Sheriff, Undersheriff, or Deputy Director of Financial and Support Services to submit a governing body resolution for the Search and Rescue Fund grant opportunity, accept grant funds, and sign any required documents required for participation in the grant program.
3. Appoints the Sheriff, Undersheriff, or Deputy Director of Sheriff's Financial and Support Services as agent to conduct all negotiations, execute and submit all documents including, but not limited to all necessary applications, strategic plans, letters of agreement, contracts, amendments, and reimbursement claims which may be necessary for obtaining financial assistance provided by Direct Relief for the Search and Rescue Fund.

BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

BE IT FURTHER RESOLVED that the County of Humboldt agrees to abide by the statutes and regulations governing the Formula Grants Program as well as the terms and conditions of the Grant Amendment set forth by Direct Relief.
