RECOMMENDATION(S):

That the Board of Supervisors appoint Sean Quincey as the county representative on the Access Humboldt Board of Directors.

SOURCE OF FUNDING:

General Fund (Franchise Fees)

DISCUSSION:

In 2006, as part of the re-negotiation of the local franchise for cable television services, a non-profit organization was created to manage public, educational and governmental access channels on behalf of the county and participating cities and to construct and maintain a Community Media Center. That organization, Access Humboldt, is governed by a Board of Directors comprised of persons elected by the organization's membership, persons appointed by the other Directors, and representatives from designated organizations including the county. The county's representative does not need to be a county employee but cannot be an elected official.

Since December 2010, the representative for the County of Humboldt has been a County Director of

Library Services. The Director of Library Services position is currently vacant prompting a request from Access Humboldt for County Administrative Officer, Amy S. Nilsen, to designate a new county representative for the term that ends in October 2017. Mr. Quincey, the County Administrative Office's Senior Administrative Analyst has expressed an interest in serving in the role of county representative for the Access Humboldt Board of Directors.

From 2010 through 2017, the county's designated representative slot was filled by a county employee, and this facilitated the flow of information regarding Access Humboldt. At this time, staff recommends that your Board appoint Mr. Quincey to fill the county representative position on the Access Humboldt Board of Directors.

FINANCIAL IMPACT:

There is no cost to the recommended action. Access Humboldt is funded in part by franchise fee revenue collected under the State's Digital Infrastructure and Video Competition Act of 2006 (DIVCA). Access Humboldt works with the county and helps to support your Board's strategic priority of inviting civic engagement and awareness of available services through its civic channel for local government programming.
