Dear Humboldt County Administrative Office:

After careful consideration, the Smart Business Resource Center regrets to inform you of our intent to terminate all contracts with County of Humboldt.

Ongoing issues with the County's inadequate performance of certain provisions of the contracts, including Smart's inability to receive contracts and payments timely, as well as ongoing additional administrative burden passed onto the Smart Business Resource Center by the Humboldt Workforce Development Board and County of Humboldt through many Humboldt Workforce Staff transitions, has created an environment that has precluded us from being able to focus on the quality workforce programming that we have been able to provide to other Northstate counties for more than 40 years. Despite multiple communications and meetings between Smart and Humboldt County administration over the past two years designed to resolve these issues, the issues have not been rectified and, in some cases, continue to escalate.

Current services scheduled for discontinuation include:

- Adult and Dislocated Worker Career Services
- Title I Youth Formula Funds for the Eureka and Eel River Valley regions
- Rapid Response and Layoff Aversion Services
- National Dislocated Worker Services for 2018 National Health Emergency Phase II Opioid Crisis
- National Dislocated Worker Services for COVID-19 Disaster Recovery
- America's Job Center of California Operator
- The Job Market website hosting and management
- The Job Market social media administration

Smart Business Resource Center will continue to serve the counties of Del Norte, Shasta, Siskiyou, and Trinity in partnership with the NoRTEC Workforce Development Board. We remain committed to workforce initiatives now and in the future with partners in Humboldt County, as our serving counties are contiguous and many of our workforce partners serve throughout this region.

In addition, Smart will continue to serve the Humboldt County community through our partnership with North Central Counties Consortium Workforce Development Board and the SB-1 grant for pre-apprenticeship in the construction trades. The grant period is January 1, 2021 – July 30, 2022 and we intend to retain our contract to serve Humboldt County through this program for the duration.

We are committed to making this transition as seamless as possible. We intend to provide services through June 30, 2021, contingent upon receiving full payment for all currently outstanding invoices no later than March 22, 2021 AND receiving weekly payments for services rendered thereafter. The first weekly payment should be received by Smart by March 26, 2021 and weekly payments should continue to be made no later than Friday of each week thereafter until all contracts are terminated and all amounts owing at that time are paid. If the County cannot accommodate this contingency, Smart will cease all services on March 26, 2021 or on the Friday following any missed weekly payment thereafter.

We are proud to have served the citizens and businesses of Humboldt County these past three years, and to have achieved the honored distinction of 2020 IEDC Excellence in Economic Development Award, on behalf of County of Humboldt, for our work on the Opioid grant. We look forward to discussing next steps to ensure continuity of Humboldt County's workforce development efforts during this time.
