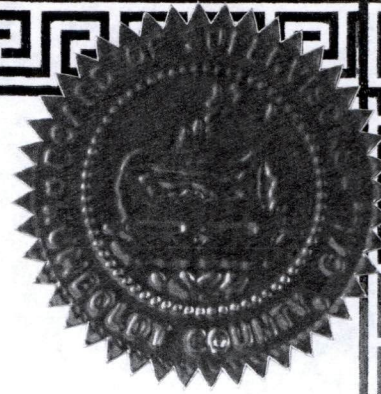

**RESOLUTION  
OF THE

WHEREAS, David Morey was hired by the Humboldt County Sheriff's Office as Deputy Sheriff on April 13, 1986; and

WHEREAS, on December 17, 1987, Dave was appointed a member of the Sheriff's Office Special Enforcement Team as a team member and trained as a first responder to critical incidents; and

WHEREAS, on March 20, 1988, David was appointed to the Sheriff's Office Marijuana Enforcement Team (MET) where he served with distinction for 19 months before returning to patrol operations; and

WHEREAS, in February of 1992, David was promoted to Sheriff's Corporal followed by promotion to Sheriff's Sergeant in June of the same year; and

WHEREAS, January 30, 1993, David resigned his position with the Humboldt County Sheriff's Office due to pending layoffs; and

WHEREAS, due to budgetary stability David sought reinstatement as a Deputy Sheriff II and on September 12, 1993 was reinstated; and

WHEREAS, in November of 1995, David was assigned to the Humboldt County Drug Task Force as an investigator for a period of two years; and

WHEREAS, on January 19, 2001, David was promoted, for a second a time, to the position of Sheriff's Sergeant assigned to the Hoopa Station; and

WHEREAS, David retained the rank of Sheriff's Sergeant for a period of five years serving in that capacity with assignments to both the Eureka Main station and McKinleyville Station; and

WHEREAS, on July 6, 2006 David, was promoted to his present rank of Sheriff's Lieutenant serving with distinction during that time period in the assignments of Commander to the operations Division, McKinleyville Station Commander, and Criminal Investigation Division Commander; and

WHEREAS, during his 28 ½ years of service David received countless letters of appreciation and commendations for his excellent service to the County of Humboldt and its residents.

NOW, THEREFORE, BE IT RESOLVED, that the Humboldt County Board of Supervisors, hereby commends and thanks Lieutenant David Morey for his dedicated 28 ½ years of service to the citizens of Humboldt County and wish him and his family well in their new adventure and home in the state of Alabama as well as a long, productive and well deserved retirement.
