WHEREAS, Steve Knight began his career with the Humboldt County Sheriff's Office as an Extra-Help Correctional Officer I on April 16, 1984; and

WHEREAS, Steve was hired by the Humboldt County Sheriff's Office as Deputy Sheriff on April 13, 1986; and

WHEREAS, on September 7, 1987 Steve was appointed a member of the Sheriff's Office Special Enforcement Team as a team member and trained as a first responder to critical incidents; and

WHEREAS, on May 14, 1988 Steve was appointed as a Field Training Officer; and

WHEREAS, in January of 1990 Steve was promoted to Sheriff's Investigator assigned to the Humboldt County Drug Task Force; and

WHEREAS, May 31, 1992 Steve was promoted to the rank of Sheriff's Sergeant assigned to the Garberville Station; and

WHEREAS, on February 14, 1993 Steve was demoted from the rank of Sheriff's Sergeant to Corporal/FTO due to county layoffs for budgetary reasons; and

WHEREAS, on June 30, 1996 Steve attend the 186th session of the FBI National Academy in Quantico, Virginia as well as POST Command College in 2007/2008; and

WHEREAS, on December 12, 1996 Steve was reinstated to the rank of Sheriff's Sergeant in charge of the Marijuana Eradication Team; and


WHEREAS, on June 10, 2001 Steve was promoted to his present rank of Sheriff's Lieutenant in charge of Criminal Investigations; and

WHEREAS, on October 21, 2003 Steve was assigned to the new Animal Control Division for the Sheriff's Office and distinguished himself during the design, construction and implementation of the new Animal Control Facility; and

WHEREAS, Steve has served in the capacity of Public Information Officer for the Sheriff's Office for the past three years and has earned the respect of many of the local news agencies.
