DISCUSSION:

Court Security budget unit 260 provides contracted bailiff/courtroom security and inmate coordination to the Superior Courts and security screening for the Courthouse entrances.

On March 10, 2015 a new contract with Securitas Security Services USA, Inc. was approved by your Board. The new contract reflected long overdue pay increases for the contractor and the second of two rate increases in this fiscal year. The increases brought the cost per hour for security screeners from \$12.94 in 2010 to \$15.16 in 2015. While there is certainly no disagreement regarding the appropriateness of the rate increase, expenses through the end of fiscal year 2014-15 have exceeded budget projections in the Services and Supplies category, and necessitate an adjustment to Court Security's budget to finish out the remainder of the year.

FINANCIAL IMPACT:

A supplemental budget in the amount of \$17,000 is requested to cover the over-expenditure of line items in Services and Supplies Category 2, as indicated below:
