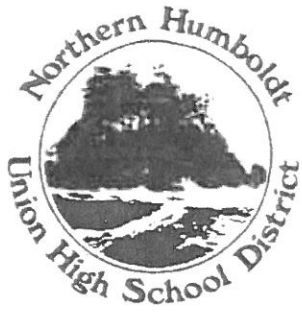

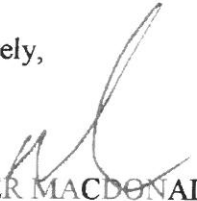
RE: Case No. CUP16-210
