#### DISCUSSION:

Costs for extra help, overtime, household expense, professional service, expense transfers and maintenance-structures were higher than what was originally estimated in the Parks & Recreation budget. Revenue from park fees and intrafund transfers from Public Works services were also higher than estimated. The requested supplemental budget is needed to adjust actual expenditures and revenues for FY 2014-15.

#### **FINANCIAL IMPACT:**

The requested supplemental budget and transfer will adjust the Parks budget up by \$24,850. There is no net impact to the General Fund. The increase in expenditures is completely offset by increased revenues.

## **ALTERNATIVES TO STAFF RECOMMENDATIONS:**

The Board could choose not to adopt the supplemental budget or approve the request for budget transfer. This alternative is not recommended because it would result in expenditures in excess of appropriations.
