This document provides a Northern Spotted Owl (NSO) habitat assessment after the Knob Fire (2021) burned ~2,421 acres surrounding the New Earth Farms cannabis project (APN: 524-072-010) to the south of Willow Creek, Ca. There were three known NSO Activity Centers (AC)(HUM049, HUM1059, HUM0050) within 1.3 miles of the project area. Two of the three NSO Activity Centers (HUM0049 and HUM1059) were located on the edge of the fire perimeter and as a result may no longer be considered NSO habitat (see attached Knob Fire perimeter map). One NSO AC (HUM0050) was located outside of the Knob Fire footprint and should still be treated as an AC. Since there is still at least one NSO AC within 1.3 miles and NSO habitat located to the south of the New Earth Farms Parcel, NSO surveys are still recommend prior to ground breaking construction relating to cannabis cultivation on APN: 524-072-010. Since there is still potential habitat to the south of the site and HUM050 was not burned during the Knob Fire NSO surveys for NSO are still recommended. Additionally, NSO that were documented in 2020 and in 2021 at HUM1059 may have relocated to a new AC within the area as a result of the Knob Fire.

The on-going Willow Creek Northern Spotted Owl Demographic study has been surveying from the early 1990s through 2022. There were five sites being monitoring by the Willow Creek Demographic study (China (HUM049), Schoo (HUM1059), Brush (HUM086), Fourm (HUM050) and Panth (HUM0325)) in the area surrounding the New Earth Farm project (See attached Willow Creek NSO survey map). As of the end of the 2021 NSO survey season, of the five NSO sites in the area, Schoo (HUM1059) is the only site that has been documented to be occupied by NSO since 2017. In 2017, 2018, 2019 and 2020 HUM1059 was occupied by a non-nesting NSO pair. NSO were not detected at HUM1059 in 2021. Additionally, a female NSO was detected near point WC 64 while surveying the FOURM site (HU050) on 6/15/20.

There were no additional NSO detections during follow-up surveys and the Willow Creek Demographic study attributed the NSO detection on 6/15/20 to the female from the Schoo site (HU1059). No additional NSO were detected outside of the historic sites in 2021. No additional surveys are recommended at this time.

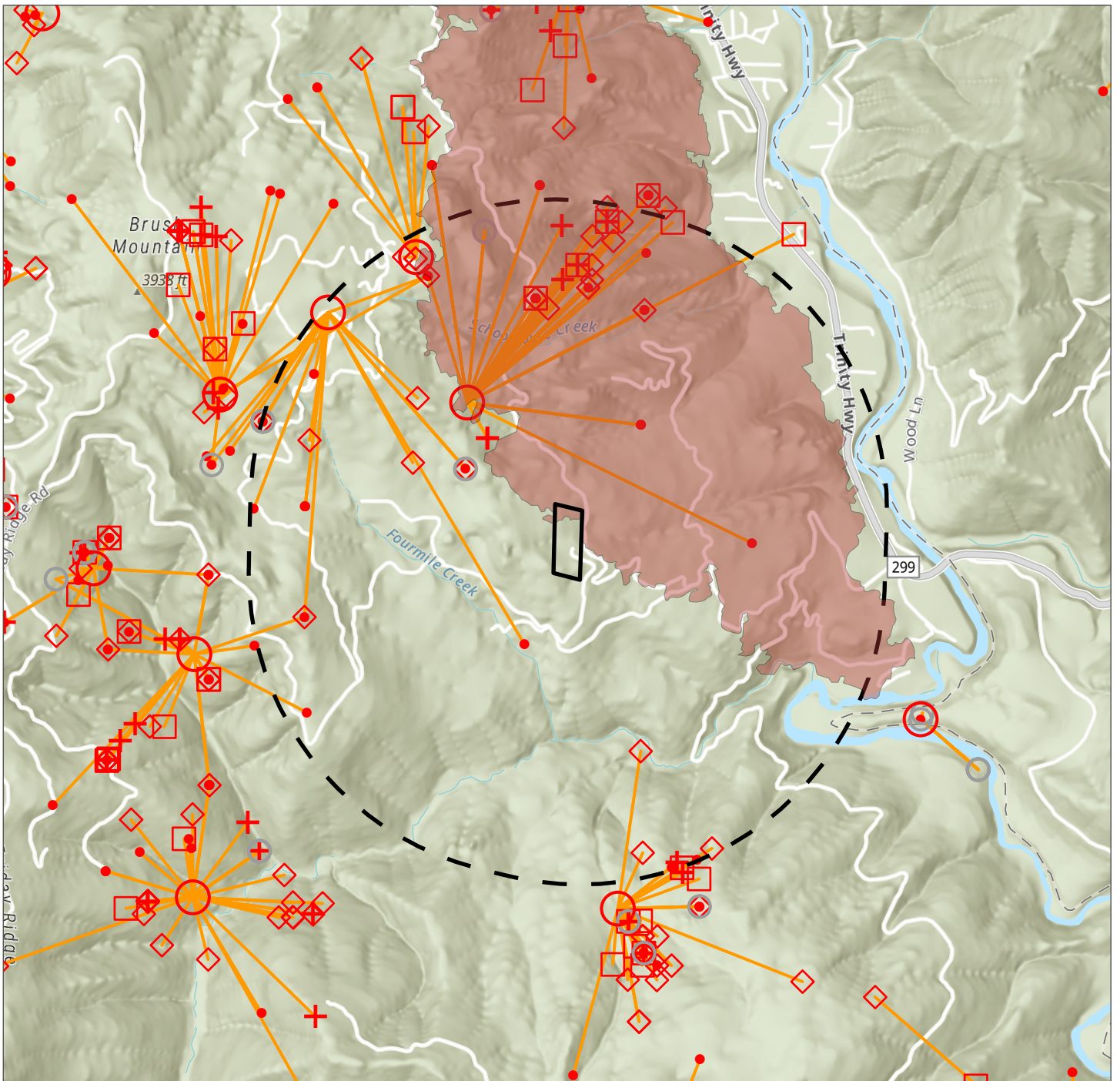

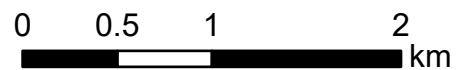


Staton Road Cannabis Project  
NSO Fire Map

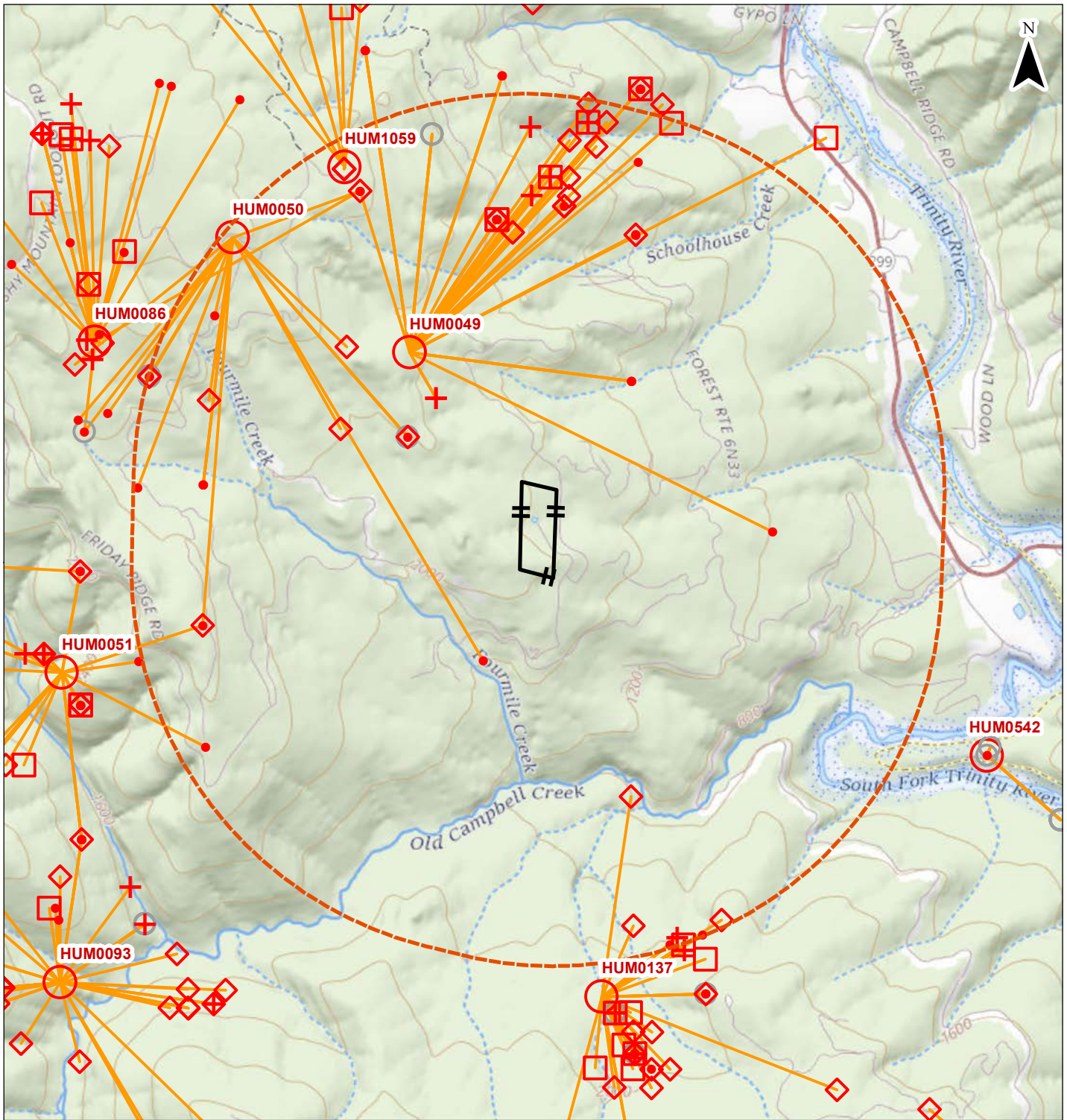
Section 17, T6N, R5E,

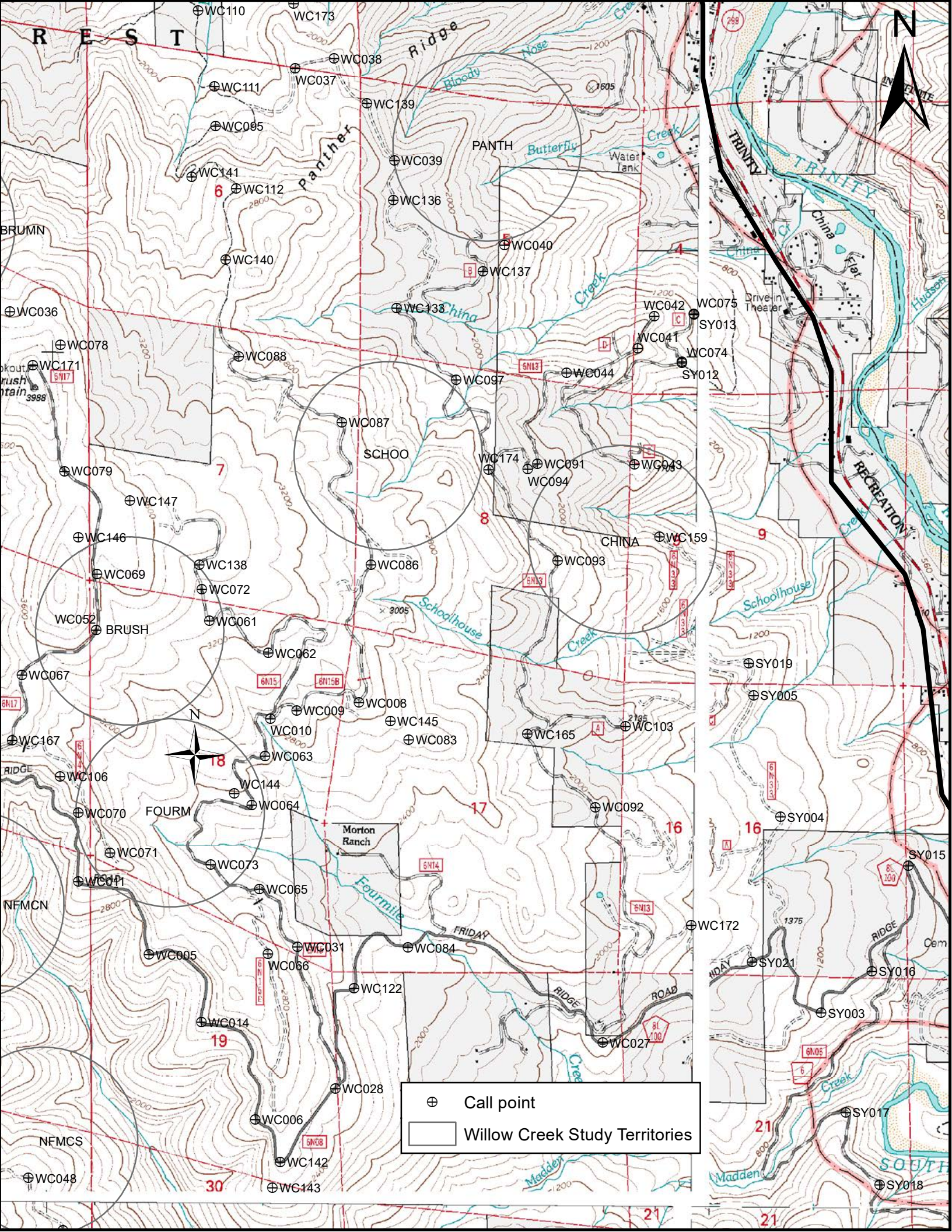
