Dear Dr. Baird,

In accordance with the requirements of §551-6 of the Humboldt County Ambulance Ordinance, we are seeking an increase in rates charged for ambulance services within Zone #1. Our last rate increase became effective September 13, 2016. The proceeds of the rate increase will offset significant increases in employee wages and declines in revenue related to call volume.

Ambulance Wages

Following the sale of the company in December 2017 the daily pay structure was changed resulting in an increase of guaranteed hours paid from 20 per day to 24. The additional hours were all paid at an overtime rate. This change alone increased payroll costs by approximately 26%. Annual cost of living adjustments of 3% a year further increased payroll and related expenses by \$35,000 per year. Although all employees had been paid at rates higher than the minimum wage, the significant annual increases in that rate have put further upward pressure on all wage rates.

Revenue

Arcata-Mad River Ambulance receives no subsidy for providing emergency and non emergency ambulance service. All our revenue is derived from fees for service and is highly dependent on the payer mix of our patient population. The proposed rate increase will have no effect on the 71% of our patients covered by Medicare and Medi-Cal as those rates are set by fee schedules. They will also have little effect on patients who are not covered by insurance and have no ability to pay. The new rates are anticipated to only apply to the 11% of our patients covered by private commercial insurance. This number is further reduced by those covered by worker's compensation insurance and some federal insurance programs, such as Tricare, as reimbursement rates from those programs are tied to the Medicare fee schedule.

Transport volume declined by 7% from 2017 to 2018 reducing revenue by an estimated \$80,000.
