Subject: Janes Creek Flood Control District

RECOMMENDATION(S):

That the Board of Supervisors authorize expenditures of up to \$8,540 toward payment for delivery and installation of a bridge to replace a culvert on Janes Creek.

SOURCE OF FUNDING:


Janes Creek Flood Control District Fund (Fund 2860)

DISCUSSION:


The Janes Creek Flood Control District was formed in 1950's in the lower reaches of Janes Creek and around the City of Arcata. Funds are collected through property taxes and deposited with the county and are available to the City of Arcata with the approval of the Board of Supervisors.

The City of Arcata is looking to remove an existing thirty-six (36) inch culvert that is failing and rusted through in several locations and replace it with a forty (40) foot long flat car bridge that they own. The culvert is on private land on Janes Creek, the City of Arcata holds a public trail easement in this area. City of Arcata needs assistance to pay the contractor for delivery and installation.



The City of Arcata is seeking Board approval to draw up to \$8,540 from the Janes Creek Flood District Fund 2860 to complete the required work.

The Janes Creek Flood District Fund will continue to accumulate revenue for future flood control efforts to benefit properties within the flood districts boundary.

FINANCIAL IMPACT:

There is no impact to the General Fund.

The current uncommitted balance in the Janes Creek Flood Control District Fund is \$8,792.99. The requested funds of up to \$8,540 will be paid to the City of Arcata to reimburse for the actual cost of delivery and installation of the bridge.

The item conforms with the Board of Supervisors' Core Role of providing for and maintaining infrastructure.
