**ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT AMENDING SECTION 421-3 RELATING TO BOULEVARD STOP IN WESTHAVEN AREA; AMENDING SECTION 421-5 RELATING TO BOULEVARD STOPS IN THE EUREKA AREA AND AMENDING SECTION 431-35 RELATING TO PARKING RESTRICTIONS IN THE ARCATA AREA, ALL OF TITLE IV OF THE HUMBOLDT COUNTY CODE.**

The Board of Supervisors of the County of Humboldt ordains as follows:

SECTION 1. Section 421-3 of Chapter 1 of Division 2 of Title IV of the Humboldt County Code is hereby amended as shown on the attached pages.

SECTION 2. Section 421-5 of Chapter 1 of Division 2 of Title IV of the Humboldt County Code is hereby amended as shown on the attached pages.

SECTION 3. Section 431-35 of Chapter 1 of Division 3 of Title IV of the Humboldt County Code is hereby amended as shown on the attached pages.

SECTION 4. This ordinance shall take effect and be in force thirty (30) days from the date of its passage. A summary shall be published at least five (5) days before the date set for adoption and again fifteen (15) days after passage of this ordinance. It shall be published once with the names of the Board of Supervisors voting for and against the ordinance in a newspaper of general circulation published in the County of Humboldt, State of California.

## TITLE IV, DIVISION 2, CHAPTER 1, HUMBOLDT COUNTY CODE

### BOULEVARD STOPS

#### 421-3. Designation of Various Stop Intersections.

#### 421-5. Designation of Various Stop Intersections.

### PARKING ZONES

#### 431-35. Parking on Fickle Hill Road.

The parking of vehicles is hereby prohibited at all times on both sides of Fickle Hill Road (County Road No. C5J040) from Post Mile 0.000 to Post Mile 0.248 (P.K. 0.000 to P.K. 0.399) and both sides of Fickle Hill Road (County Road No. C5J040) from Post Mile 10.819 to Post Mile 11.150 (P.K. 17.411 to P.K. 17.944).
