## NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The Public Defender is hereby authorized and directed to accept Indigent Defense Program grant funds in the amount of \$93,100.
- 2. The Public Defender, or a designee thereof, is hereby authorized and directed to act on behalf of the County in connection with the allocation of the Indigent Defense Program funding, to enter into, execute and deliver any and all documents required, or deemed necessary or appropriate, to accept and secure such funding and the County's obligations related thereto.
- 3. The County hereby certifies and represents that HCCC will utilize any and all Indigent Defense Program funding allocated thereto in accordance with any and all applicable local, state and federal terms, conditions, laws, regulations, standards and requirements.
