My name is Kelsey Boyd, and I'm writing in strong support of the We Are Up development proposed for McKinleyville.

In my work as a coordinator in the behavioral health field here in Humboldt County, I regularly speak with families and caregivers who describe themselves as isolated and exhausted. These are families caring for loved ones who have different ways of communicating their needs and emotions - individuals who often struggle to access the systems many of us move through with ease: schools, apartments, jobs, and transportation.

Many of these individuals and their caregivers have spent years isolated within their own homes. This deepens the emotional, financial, and psychological toll of their daily lives and often leaves them feeling disconnected from the broader community. A number of these families are caught in a fragile cycle - dependent on In-Home Supportive Services (IHSS) to survive, while housing access is directly tied to their ability to serve as full-time caregivers, regardless of whether that arrangement offers the best quality of life for those involved.

The We Are Up development presents a bold and compassionate alternative. This project would not only bring a much-needed source of hope to the neurodiverse and disability communities in Humboldt - it would also enrich the social, economic, and cultural fabric of McKinleyville as a whole.

By introducing a significant number of new housing units, We Are Up directly addresses our community's housing shortage. Its integration of community-supported agriculture, access to nature, and proximity to small businesses builds on McKinleyville's roots and growing economic core while offering something visionary: a place where individuals of all abilities, ages, and backgrounds can thrive.





I am writing, as CEO and Co-founder of The Kelsey, to express our enthusiastic and unqualified support for the We Are Up inclusive housing community proposed in McKinleyville.

The Kelsey is a nationally recognized nonprofit that advances disability-forward housing solutions through development, advocacy, and technical assistance. We have successfully completed two inclusive, affordable housing communities in the Bay Area - *The Kelsey Ayer Station* in San Jose and *The Kelsey Civic Center* in San Francisco - in partnership with local Regional Centers, the cities of San Jose and San Francisco, and the State of California. These communities demonstrate how disability-inclusive housing can be financially feasible, socially impactful, and replicable across geographies.

We Are Up engaged The Kelsey in 2023 to serve as a technical assistance and development advisor, and we've worked closely with them ever since. Based on our experience and expertise, we've supported We Are Up through the predevelopment, design, and planning phases, and we are continuing to provide strategic guidance as they move into construction and financing.

Our partnership has included:

- **A comprehensive feasibility analysis**, confirming the financial viability of a 70-unit inclusive community, including public and private financing paths such as 9% and 4% LIHTC, various federal and HCD programs, DDS grants, and concessionary equity, among others.

- A **series of co-led design charrettes** focused on cognitive access needs and universal design strategies - ensuring that residents with intellectual and developmental disabilities (I/DD) and other disabilities are considered at every level of design.
- **Hosting the We Are Up team at our San Jose community**, where they toured The Kelsey Ayer Station, met with current and future residents, and participated in collaborative design workshops to adapt best practices to the Humboldt context.
- Ongoing support with **capital stack development**, public financing navigation, and co-developer structuring - ensuring We Are Up is positioned to attract the investment and partnerships needed to bring this vision to life.

This is more than a housing project. It is a transformative model for rural, intergenerational, and disability-forward community development. The proposed design includes ADA-compliant and adaptable units, a community center, on-site job training opportunities, and sustainable features like a commercial greenhouse and meadow trail. With 25% of units prioritized for residents with I/DD, and thoughtful consideration for healthcare workers, older adults, and low-income households, We Are Up is responding directly to community needs while advancing equity and inclusion.

We Are Up's commitment to meaningful inclusion, sustainable development, and affordability is rare - and it has been a privilege to walk alongside them in shaping this vision. We strongly urge the Commission to approve this project and help bring this nationally significant model to life in Humboldt County.



The project will offer 70 units of affordable housing to adults with intellectual and developmental disabilities, seniors, and other community members. The site will also offer temporary housing for visiting or relocating medical professionals to help address chronic healthcare workforce shortages often attributed to the lack of housing in our rural community.

In addition to housing, We Are Up will offer community and a sense of belonging to those who live on site. There will be many opportunities for residents to connect to each other through gardening, job training, enrichment classes, and life skills. And with a commercial kitchen and modern event spaces, We Are Up will also be a gathering place for the larger community of Humboldt County for weddings, commercial kitchen use, and corporate events. By concentrating the development on a corner of the 17 acres, We Are Up will also preserve the vast majority of the land – over 80% – as open space for walking trails, contemplation, and outdoor education. Another environmental benefit of the project is the anticipated reduction of vehicle miles driven given the site's close proximity to grocery, pharmacy, health care, banking, bus line, and many other needs of daily life.

I support this project because of the tremendous need for supportive housing in Humboldt County, where almost none exists. I also support it because of the care and thoughtfulness with which We Are Up has approached the planning and layout of the community so as to minimize disruption to the existing neighborhood and the natural features of the land. It is this balance that makes the We Are Up project so unique – it simultaneously meets the undisputed need to provide housing and support for some of Humboldt County's most vulnerable populations, while preserving open spaces and the status quo on the vast majority of the land.

I also support We Are Up's plan to build a commercial greenhouse, garden space, an orchard and shelters or pens for livestock. These features will have many community benefits, including promoting

farm-to-table food production, contributing to the economic development of the surrounding community, and providing employment opportunities for residents. It is also important to remember that the use of this land for these purposes is nothing new, but rather continues the historic agricultural uses of the site.

I will take Tate to the Eureka Symphony and my husband will take Caden roller skating at the municipal auditorium, or vice versa. We love taking trips together, we just don't go too far from home. We rent beautiful homes on the ocean, or a house during the summer with a big pool and hot tub. We still make memories as a family and the kids feel safe and secure. 
