THIRD AMENDMENT PROFESSIONAL SERVICES AGREEMENT BY AND BETWEEN COUNTY OF HUMBOLDT AND

This Second Amendment to the Professional Services Agreement dated October 20, 2020 (the "Agreement"), by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Humboldt State University Sponsored Programs Foundation, hereinafter referred to as "CONTRACTOR," is entered into this day of June, 2023.

WHEREAS, the Parties entered into the Agreement for Contractor to provide Workforce Innovation and Opportunity Act (WIOA) Rapid Response and Layoff Aversion Services which became effective on July 1, 2021; and

WHEREAS, the Parties previously amended the Agreement on June 28, 2022; and

WHEREAS, the Parties now wish to: (1) extend the term of the Agreement, and (2) update the Invoice that was attached to the Agreement as Exhibit B.

NOW THEREFORE, the parties mutually agree as follows:

- 1. Section 2 TERM is amended to read as follows:
 - 2. TERM:

This Agreement shall be effective commencing July 1, 2021 upon execution by both parties and shall remain in full force and effect until December 31, 2023.

- 2. The Agreement is amended to delete Exhibit D Invoice and replace it in its entirety with the modified version of Exhibit D that is attached hereto and incorporated herein by reference as if set forth in full. The modified version of Exhibit D attached hereto shall supersede any and all prior versions thereof as of the effective date of this Third Amendment.
- 3. Except as modified herein, the Agreement, as amended, shall remain in full force and effect. In the event of a conflict between the provisions of this Third Amendment and the original Agreement or the First Amendment, the Second Amendment, the provisions of this Third Amendment shall govern.
