SUBJECT:

Trial Court Trust Fund Recording Fee Reallocation.

RECOMMENDATION(S):

That the Board of Supervisors:

1. Approve the redistributions of fees collected from \$3 for each additional page of recordable documents as follows: deallocate \$1 from the Trial Court Trust Fund and allocate \$1 to the General Fund, Clerk/Recorder (1100271).

SOURCE OF FUNDING:

General Fund - Clerk/Recorder, 1100271-617000 Recording Fees

DISCUSSION:

In 1997, the Trial Court Trust Fund was established, funded in part by recorder fees as per GC 68085. A 2000 amendment removed Recorder Fee Code (GC 27361) from this arrangement.

Currently, for each additional recorded page, \$3 is charged and is distributed as follows: \$1 to Modernization, \$1 to the General Fund, Clerk/Recorder (1100271) and \$1 to the Trial Court Trust Fund.

The proposed change will adjust this allocation to \$1 to Modernization and \$2 to the General Fund, Clerk/Recorder (1100271), maintaining compliance with the Government Code without increasing overall fees.
