**RESOLUTION NO. 23-136**

**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING THE HUMBOLDT COUNTY DEPARTMENT OF PUBLIC WORKS TO ACCEPT FUNDING MADE AVAILABLE THROUGH THE CALIFORNIA DEPARTMENT OF TRANSPORTATION FOR REPLACEMENT OF THE HAMMOND TRAIL BRIDGE OVER THE MAD RIVER.**

**WHEREAS**, the County of Humboldt is eligible to receive federal funding made available through the California Department of Transportation under the Community Project Funded Congressionally Directed Spending Program for replacement of the Hammond Trail Bridge over the Mad River.

**NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:**

1. The Humboldt County Board of Supervisors wishes to program Community Project Funded Congressionally Directed Spending Program funds for replacement of the Hammond Trail Bridge over the Mad River ("Project").
2. The Humboldt County Department of Public Works is hereby authorized and directed to accept funding made available through the California Department of Transportation for the Project.
3. The Humboldt County Public Works Director, or a designee thereof, is hereby authorized and directed to conduct negotiations, execute, submit and sign any and all documents, including, without limitation, applications, grant agreements, amendments, payment requests and other documents, which may be necessary to accept and secure Project funding and/or complete the Project.
4. The County of Humboldt hereby represents and certifies that it will comply with any and all local, state and federal laws, regulations and standards, as well as the terms and conditions specified in any and all agreements, applicable to the Project.
5. The County of Humboldt hereby represents and certifies that it will obtain any and all appropriate permits applicable to the Project.
