RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING THE DISTRICT ATTORNEY'S OFFICE TO ACCEPT AND APPLY FOR ADDITIONAL GRANT FUNDING MADE AVAILABLE THROUGH THE CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES VICTIM WITNESS ASSISTANCE PROGRAM

WHEREAS, the County of Humboldt ("County"), by and through the Victim Witness Unit of the Humboldt County District Attorney's Office, is required to provide comprehensive services to victims and witnesses of all types of violent crime, pursuant to California Penal Code Section 13835; and

WHEREAS, the County submitted an application for grant funding made available through the Victim Witness Assistance Program; and

WHEREAS, The California Governor's Office of Emergency Services subsequently awarded the County Victim Witness Assistance Program funding in the Amount of Four Hundred Thirteen Thousand Two Hundred Thirty-Seven Dollars (\$413,237.00) in fiscal year 2023-24, October 1, 2023 - September 30, 2024, in order to allow for the provision of increased direct services to victims and witnesses in Humboldt County.

WHEREAS, The California Governor's Office of Emergency Services has opened the application process for funding made available through the Victim Witness Assistance Program in the amount of Four Hundred Four Thousand Three Hundred Ninety-Six Dollars (\$404,396.00) for fiscal year 2024-25, October 1, 2024 – September 30, 2025, to provide the provision of increased direct services to victims and witnesses in Humboldt County.

WHEREAS, The County wishes to apply for additional funding made available through the California Governor's Office of Emergency Services Victim Witness Assistance Program.

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The County's submission of an application for grant funding made available by the California Governor's Office of Emergency Services through the Victim Witness Assistance Program submitted by the District Attorney's Office on June 29, 2023, is hereby ratified.
- 2. The Humboldt County District Attorney is hereby authorized to submit an application for the additional grant funding made available through the California Governor's Office of Emergency Services Victim Witness Assistance Program.
- 3. The Humboldt County District Attorney and the Humboldt County Auditor-Controller, or designees thereof, are hereby authorized to execute on behalf of the County of Humboldt any and all documents necessary to apply, accept, secure and administer including modifications or amendments to the Victim Witness Assistance Program funding awarded by the California Governor's Office of Emergency Services.
- 4. The County shall not use any of the grant funds received through the Victim Witness Assistance Program to supplant expenditures controlled thereby.
