This application requests a child safety equipment package of 50-200 convertible child safety seats and 50-200 booster seats, in neutral colors, consistent with the information and requirements found in the IVPB Child Safety Equipment Request for Application (RFA), September 2022.

BY APPLYING FOR THE SAFETY EQUIPMENT, YOUR AGENCY AGREES TO ABIDE BY THE TERMS OUTLINED BELOW. ALL SAFETY EQUIPMENT MUST BE PROVIDED:

1. Free of charge;
2. To children of families with low income. Examples of low-income can include, but are not limited to: provided to children from a school with 75 percent or more of students eligible for Free or Reduced Price Meals; provided to children in a census tract with mostly low income households; provided by an organization that primarily works with families with low incomes; or provided to children based on self-reporting of low income status; and
3. To the public by a certified Child Passenger Safety Technician who will provide education and demonstrate proper installation, as follows nationally recommended best practice.

Awardees must distribute their allotted safety equipment by June 30, 2023. The attached form is intended to record the distribution of all safety equipment (target audience, type of education provided, proof of low income). All awardees will be asked to complete and return the record of distribution by June 30, 2023.

Select number of each type of seat requesting. Both types of equipment must be checked. For example, you may want 100 convertible seats and 50 boosters.
