- 1. The Planning Commission adopts the proposed Addendum to the previous Negative Declaration in Attachment 5, as required by Section 15074(b) of the CEQA guidelines, and finds that there is no substantial evidence that the proposed project will have a significant effect on the environment; and
- 2. The Planning Commission makes the findings in Attachment 2 of the Planning Division staff report for Case Number PMS-14-010 based on the submitted evidence; and

3. The Planning Commission conditionally approves the Parcel Map Subdivision as recommended in the Planning Division staff report for Case Number PMS-14-010; Assessor's Parcel Number 018-121-041-000.
