

DISCUSSION:

Mad River Beach County Park is available for day-use by the community to participate in such activities as picnicking, beachcombing, fishing and wildlife viewing. This area is considered to have two parks; one being the beach, the other a large parking area, restroom and boat ramp leading into the Mad River. The Sheriff's Office has received an increasing number of complaints from the community regarding the discharge of firearms in the Mad River Beach County Park area, which is negatively affecting the community's ability to enjoy both of these park areas.

Two sections of the County Code regulate the discharge and possession of firearms in this area. County Code 915-6, Firearm Discharge Prohibition Zone Mad River Beach Area, discusses that "no person shall fire or discharge, or cause to be fired or discharged, any firearm on, into, or over any public place..." County Code 271-6, Weapon Possession Prohibition Zone Mad River County Park, discusses that "no person while in Mad River County Park shall have in his or her possession or under his or her custody or control any weapon, except as provided in County Code Section 271-6(b).

In order for the Humboldt County Sheriff's Office to enforce County Codes 915-6 and 271-6, firearm and weapon regulation signs need to be posted. However, there are no signs in the Mad River Beach_County Park area with these regulations posted.

FINANCIAL IMPACT:

There is limited financial impact to the General Fund associated with the purchase of firearm regulation signs.

The purchase of the firearm regulation signs meets the Board of Supervisors Strategic Framework by enforcing laws and regulations to protect residents.

OTHER AGENCY INVOLVEMENT:

None

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board could deny the request to approve the supplemental budget; however, this is not recommended as these signs are needed to inform the public of County Codes 915-6 and 271-6 so enforcement action can be taken.

Firearms and Weapon Regulations Information Sheet

Firearm and Weapon Regulations



Firearm Discharge Prohibition Zone Mad River Beach Area (County Code 915-6)

No person shall fire or discharge, or cause to be fired or discharged, any firearm on, into, or over any public place, including waters, located within the zone depicted on this map, except as provided in County Code Sect. 915-7.

"Public Place" means any area open to common, or general use, participation or enjoyment, including, but not limited to, such areas as beaches, parks, parking areas, roadways, trails and other areas which are open and accessible to the public.



Firearm Discharge Prohibition Zone

Weapon Possession Prohibition Zone Mad River County Park (County Code 271-6)

No person while in Mad River County Park shall have in his or her possession or under his or her custody or control any weapon, except as provided in County Code Sect. 271-6(b).

"Weapon" includes any firearm of any size or description, air rifle, pellet gun, spring gun, bow and arrow, sling, or any other weapon or instrument which when so used creates a significant risk of harm to wildlife or human safety, or any instrument that can be loaded with and fire blank cartridges.
