- Section 105 1.2.2 remove allowance for translucent covers in Coastal Zone.
- Under exemptions allow lighting for flags subject to State and US flag code but remove statues as something that can be illuminated.
- Under exemptions allow use of string lights before 10:00 PM.
- Remove athletic field lighting from exemptions and require a Conditional Use Permit.
- Section 105.1.4 add the night sky and biological resources in inland area is exceptions to exemptions and in the coastal ordinance change ESHA for biological resources.

And bring back a street lighting ordinance that also addresses parking lots with language to have motion activated lighting and dimmers in parking lots by the end of the calendar year.

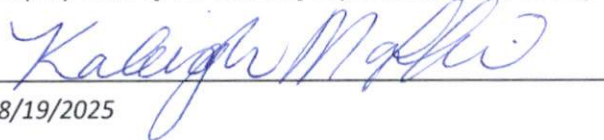

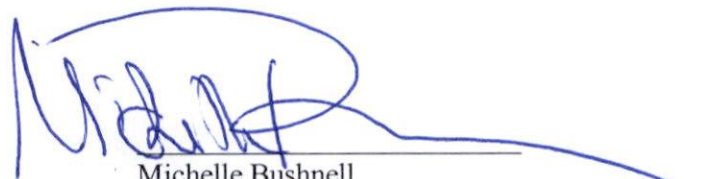
