WHEREAS, Humboldt County entered into a Master Local Agency -State Agreement for Federal Aid Programs on <u>June 5, 2007</u>; and

WHEREAS, Federal Transportation legislation has established annual allocations to Humboldt County of Federal Funds for transportation related projects; and

WHEREAS, the State of California legislation allows Humboldt County to exchange the Federal Allocation for nonfederal State Highway Account funds and Humboldt County has historically exchanged the Federal Allocation for nonfederal State Transportation Funds; and

WHEREAS, Humboldt County and the State of California are willing to enter into an agreement that specifies these State Funds be used for transportation purposes in conformance with Article XIX of the California State Constitution; and

WHEREAS, Agreement No. X23-5904(191) will allow Humboldt County to exchange FY 22/23 Federal Allocation funds for nonfederal State Transportation Funds; and

WHEREAS, the State of California, Department of Transportation, requires a
