RE: PROPOSED VACATION OF PUBLIC UTILITY EASEMENT AJACENT TO KRISTIN WAY (COUNTY ROAD NO. 4L851) IN MCKINLEYVILLE

The Department of Public Works is preparing documents for the proposed vacation for the reduction of a 25-foot-wide public utility easement located adjacent to Kristin Way. There will continue to be a 20-foot-wide utility easement. The easement was created by Tract No. 388, recorded October 6, 1992, in Book 20 of Parcel Maps, pages 96-98. The areas proposed for vacation is located in the Northwest quarter of Section 8, Township 6 North, Range 1 East, Humboldt Meridian. The public utility easement to be vacated is shown on the attached "Exhibit B".

Please review the attached map and advise the Department if AT&T has any facilities that would be affected by the proposed vacation.


