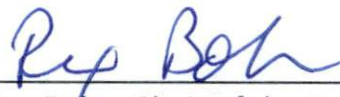
**A RESOLUTION OF BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT
AUTHORIZING THE GRANT APPLICATION FOR THE STATEWIDE FLOOD EMERGENCY
RESPONSE (ER) GRANT**

WHEREAS, The Sheriff's Office, Office of Emergency Services (OES) proposes to implement flood response planning and materials projects; and

WHEREAS, The Sheriff's Office, Office of Emergency Services intends to apply for grant funding from the California Department of Water Resources for the project costs;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Humboldt as follows:

1. That pursuant and subject to all the terms and provisions of California Proposition 84, The Safe Drinking Water, Water Quality & Supply, Flood Control, River & Coastal Bond Act of 2006 (Section 75032 of Chapter 3 of Division 43 of the Public Resources Code), application by this Agency be made to the California Department of Water Resources to obtain a grant for the update of the Humboldt County Flood Contingency Plan, development of a Levee Safety Plan, implementation of levee assessment/monitoring/safety training, and purchase of flood fight materials and emergency lighting.
2. The Humboldt County Sheriff, Undersheriff, Sheriff's Office Deputy Director, and Emergency Services Program Manager are hereby authorized and directed to prepare the necessary data, make investigations, sign, and file such application with the California Department of Water Resources, and take such other actions as necessary or appropriate to obtain the grant funding.
