- 1) Accepts the completed contract, including all change orders approved by the Public Works Department, between Tidewater Contractors, Inc., and Humboldt County for the Bald Hills Road Improvement Project.

DISCUSSION:

This project consisted of road rehabilitation along an approximately a 3.15 mile long stretch of Bald Hills Road between post miles 19.04 and 22.19, situated just east of the boundary of Redwood National Park. Bald Hills Road is a rural major collector road in northern Humboldt County and the primary route connecting the upper and lower portions of the Yurok Reservation. The existing road within the project area was a gravel-surfaced, two-lane road in poor condition. In some locations, the width of the roadway is sufficient to only permit one-way traffic. The purpose of the project was to stabilize and protect the roadway, improve driving conditions,

create safer road conditions, reduce road maintenance needs and reduce dust generation, erosion, and sediment runoff. The project has stabilized existing structural sections, improved drainage, and provided continuous asphalt paving on the road surface. The project also included localized shoulder widening, retaining wall construction, metal beam guard rail installation, and road striping.

On March 19, 2013, the Board of Supervisors authorized the Clerk of the Board to advertise the above-referenced project for bids. On April 23, 2013, the county received six (6) bids for the project. The project was awarded to Tidewaters Contractors, Inc., the lowest responsive bidder on May 21, 2013. The award amount was \$1,656,064.50. Change orders through project completion amounted to an increase of \$40,348.37.

FINANCIAL IMPACT:

Total construction costs for this project were \$1,696,412.87. This project is being funded through the Bureau of Indian Affairs, which will provide 100 percent of the construction costs. Public Works costs, including project engineering, inspection and administration, will be reimbursed by the Bureau of Indian Affairs

This project conforms to the Board of Supervisors' Strategic Framework by protecting vulnerable populations and building interjurisdictional and regional cooperation.
