**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT
RESCINDING THE REVOCATION OF THE PACWI LLC CONDITIONAL USE PERMIT, RECORD
NUMBER PLN-12049-CUP FOR APN 216-093-009**

WHEREAS, the Board of Supervisors held a duly-noticed public hearing on May 12, 2026, and voted to revoke the permit issued to PACWI, LLC due to failure to pay Measure S taxes; and

WHEREAS, shortly after this action was taken the permit holder contacted the County and raised questions about whether proper notice had been given to the permit holder, and immediately paid the past due Measure S taxes; and

WHEREAS, on June 16, 2026, as part of the consent agenda the Board of Supervisors approved an action to rescind the May 12th action revoking the permit for PACWI, LLC.

NOW, THEREFORE, the Board of Supervisors does hereby:

a. Rescind the action taken on May 12, 2026, revoking the Conditional Use Permit for APN 216-093-009.
