**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT APPROVING THE ZONE RECLASSIFICATION PETITION APPLICATION FOR FILE NUMBER APNS 203-211-008, -009, -010, -011, -012, -013, -014, -015, -016, -017 & -018 CASE NUMBER PLN-2020-16209**

**WHEREAS**, Section 312-50.2 of the Humboldt County Code (HCC) allows the Board of Supervisors to initiate, grant, deny, or modify proposed amendments to Zoning Regulations; and

**WHEREAS**, Section 312-50.4 HCC allows a property owner to petition the Board of Supervisors to initiate a zone reclassification; and

**WHEREAS**, Section 312-50.5.2 HCC requires that the petition demonstrate that the change will be in the public interest and consistent with the General Plan; and

**WHEREAS**, the petition to accept an application for a zone reclassification is not a project as defined in Section 21065 of the Public Resources Code and is not subject to CEQA.

**NOW, THEREFORE, BE IT RESOLVED** by the Humboldt County Board of Supervisors that the following findings are hereby made:

1. There is factual evidence in support of the petition for zone reclassification; and
2. The petition is in the public interest and is consistent with the General Plan.

**BE IT FURTHER RESOLVED** that based on the above findings, and evidence in the file for the project, , the Board of Supervisors accepts the McKenny Zone Reclassification Petition, Case No. PLN-2020-16209; and

**BE IT FURTHER RESOLVED** that the Clerk of the Board is directed to provide notice of this decision to all interested parties.
