

NATURA BLUE INC. IS PROPOSING TO PERMIT EXISTING CANNABIS CULTIVATION ACTIVITIES ON APN:210-062-007 IN ACCORDANCE WITH THE COUNTY OF HUMBOLDT'S (COUNTY) COMMERCIAL MEDICAL MARIJUANA LAND USE ORDINANCE (CMLLUO), ORDINANCE NO. 2559. THE EXISTING OPERATION INCLUDES APPROXIMATELY 36,256 SQUARE FEET (SF) OF OUTDOOR CANNABIS CULTIVATION. WATER FOR THE CULTIVATION IS PROPOSED THROUGH A PERMITTED WELL AND AN EXISTING 1.3 MILLION GALLON RAIN CATCHMENT POND. THE PRE-EXISTING CULTIVATION HAS PREVIOUSLY USED 2 LARGE GENERATORS AND IS PROPOSING TO TRANSITION TO SOLAR IN 2 YEARS FROM THE APPROVAL DATE.

TRIMMING, DRYING, AND HARVEST STORAGE WILL OCCUR AT THE EXISTING FACILITY ON APN:210-054-008 (SAME LEGAL PARCEL).

1. DRAWING SCALE AS NOTED. WRITTEN DIMENSIONS SHALL TAKE PRECEDENCE OVER SCALED DIMENSIONS.
2. THE SOUTHEAST CORNER WAS SURVEYED BY KOLSTAD LAND SURVEYORS IN 2017. THIS BOUNDARY INFORMATION HAS BEEN DEPICTED BY NORTHPOINT CONSULTING GROUP. THE REMAINING PARCEL INFORMATION IS FROM HUMBOLDT COUNTY 2015 GIS DATA. NORTHPOINT CONSULTING GROUP, INC. HAS NOT VERIFIED THIS PROPERTY BOUNDARY.
