RESOLUTION OF THE BOARD OF SUPERVISORS COUNTY OF HUMBOLDT

WHEREAS, Carol Rische has served as General Manager of the Humboldt Bay Municipal Water District (HBMWD) since 2000, and for the last 15 years has been a leader in providing potable water to the Humboldt Bay area; and

WHEREAS, Carol began her career as an engineer with PG&E in 1984 and subsequently worked at numerous positions with PG&E before coming to HBMWD in 1996; and

WHEREAS, Carol obtained a degree in Mechanical Engineering from UC Davis, where she also set several records for the women's basketball team that still stand today. She went on to obtain her MBA from CSU Hayward while working for PG&E, and also earned a Management of Human Resources certification from UC Berkley and participated in Leadership 2000, a national leadership program sponsored by the University of North Carolina and the Brookings Institute; and

WHEREAS, Carol exemplifies what it means to be an engineer.....she not only engages in the technical aspects of engineering, but also excels at the public involvement and protection aspects of the profession that all engineers should practice. Carol serves as a role model, not only for women engineers, but for all engineers, and sets a standard that every engineer should strive to meet; and

WHEREAS, Carol has served as a leader in the community in numerous environmental, public health, community governance, regulatory oversight, and community volunteering endeavors, and her accomplishments while at the Humboldt Bay Municipal Water District are all-telling of her commitment to service and community wellbeing; and

WHEREAS, Carol has been a member of Eureka Rotary since 2000 and has served as the Chair of the small grants committee, which provides grant monies to local educational, health, and other agencies that serve the local community. She has also chaired the scholarship committee, which provides scholarships for local college students, and served as the coordinator of the Backpacks for Kids program, which provides backpacks filled with food for the weekend for needy local grade school students; and

WHEREAS, Carol has served on the Board of the Senior Resource Center. The Center provides services, information, education, and recreation for seniors, families and caregivers in Humboldt County. Carol was actively involved in providing the direction for the Center and was particularly active in the home-delivered meals program; and

WHEREAS, in July, 2015, Carol Rische is retiring and the community will be losing a valuable public-sector engineer. However, knowing Carol....she will continue to be heavily involved in the community for years to come.
