**Recommendations for Measure Z Expenditures**

The Citizens' Advisory Committee on Measure Z Expenditures has been tasked with assisting the Board of Supervisors in taking public input on the expenditure of funds derived from the county-wide local sales tax imposed pursuant to Measure Z. Thirty applications for funding were received from various county departments and outside agencies. Three meetings were held, to examine the various proposals received and weigh the value of each. The Committee has been asked to make recommendations on which proposals should be funded, given the projected amount of revenue expected from the county-wide local sales tax.

All applications were reviewed and considered. The Committee sorted the applications into "yes" and "no" categories, then prioritized those with a majority "yes" vote into level 1, 2 and 3, with level 1 being of the highest priority. The committee then further refined the list by prioritizing applications with equal scores using the same methodology. Through this ranking process, the committee developed a single, prioritized list for your Board's consideration. The list begins with the highest priority applications, allowing for the Board to make additional allocations from the list should additional funding become available at first quarter and mid-year.

The following recommendations would allocate \$4,503,663 for a combination of one-time and ongoing expenses as part of the annual budget process. The committee understands that adjustments to these recommendations may be required to present a balanced proposed budget:
