RESOLUTION

WHEREAS, Carolyn Crnich, Clerk Recorder is a fifth generation native of Humboldt County and has been married to her husband William Crnich for 42 years. On January 5, 2015, Carolyn retired from the Humboldt County Clerk Recorder's Office after 39 years of dedicated service to the people of Humboldt County; and

WHEREAS, Carolyn was hired in the Assessor's Office in July, 1976 as a Map Drafting & Title Clerk, and was promoted to Senior Map Draftsman in March, 1979; and

WHEREAS, in October, 1980, Carolyn was again promoted to the position of Cadastral Drafting Supervisor and held that position until January, 1991; and

WHEREAS, in 1990, Carolyn was elected Humboldt County Recorder, a post she has held for six consecutive terms; and

WHEREAS, in 1997, the duties of the County Clerk were consolidated with the County Recorder; and

WHEREAS, in 2005 the duties of the Registrar of Voters was consolidated with the Clerk/Recorder's Office; and

WHEREAS, in 2007, Carolyn was certified as a California Registered Elections Official by The Election Center, Houston Texas and the California Association of Clerks & Elections Officials; and

WHEREAS, in 2009, Carolyn was named the AAUW Women's History Month honoree. She is a member of the Eureka Rotary Club, the League of Women Voters, the Humboldt Election Transparency Project, and a past member of the Board of Directors of St. Joseph Health System; and

WHEREAS, Carolyn was a key member in the formation of the Humboldt Election Transparency Project, and since 2009, the Transparency Project and its members have received awards from the National Association of Secretaries of State, the Lori Grace Foundation for Election Integrity, the Election Verification Network, the Patriot Award from the local branch of the ACLU, and the local Civil Liberties Monitoring Project; and

WHEREAS, Carolyn's professionalism and management skills have made her an asset to the Office and to the citizens of Humboldt County.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors hereby commends and thanks Carolyn Crnich for her dedication and service to the citizens of Humboldt County and wishes her success in her retirement.
