**RESOLUTION OF THE COUNTY OF HUMBOLDT BOARD OF SUPERVISORS  
AUTHORIZING THE DIRECTOR OF AVIATION TO ACCEPT ALLOCATION OF GRANT  
FUNDS AND EXECUTE ALL NECESSARY DOCUMENTS RELATED TO THE GRANTS**

**WHEREAS**, the County of Humboldt has a need to improve the planning, safety, and infrastructure for its six-airport system; and

**WHEREAS**, the County of Humboldt Department of Aviation submitted to the FAA Project Applications, dated April 1, 2022, for grants of federal funds for projects at or associated with the California Redwood Coast-Humboldt County Airport (ACV) System; and

**WHEREAS**, the FAA has approved projects for the California Redwood Coast-Humboldt County Airport consisting of the following: Rehabilitate Runway 14/32 and Improve Electrical System – Phase 2, Construction; and, Runway Rehabilitate and Electric Improvements - Reimbursable Agreement (the “Projects”); and


**WHEREAS**, pursuant to and for the purpose of carrying out the Title 49, United States Code (U.S.C.), Chapters 471 and 475; 49 U.S.C. §§ 40101 et seq., and 48103; FAA Reauthorization Act of 2018 (Public Law Number 115-254); the Department of Transportation Appropriations Act, 2021 (Public Law 116-260, Division L); the Consolidated Appropriations Act, 2022 (Public Law 117-103); and the representations contained in the Project Application; and in consideration of: (a) the Sponsor’s adoption and ratification of the Grant Assurances attached hereto; (b) the Sponsor’s acceptance of this Offer; and (c) the benefits to accrue to the United States and the public from the accomplishment of the Project and compliance with the Grant Assurance and conditions as herein provided; the Federal Aviation Administration has allocated to Humboldt County Department of Aviation funding that has been made available through the Airport Improvement Program; and

**WHEREAS**, both FAA Grant Offers for Airport Improvement Program (“AIP”) Projects Nos. 3-06-0010-054-2022 and 3-06-0010-053-2022 require the Board of Supervisors to give authority to execute the grants to the individual signing them, the Director of Aviation or his designee.

**NOW, THEREFORE, THE COUNTY OF HUMOLDT BOARD OF SUPERVISORS  
HEREBY RESOLVES AS FOLLOWS:**

1. The Director of Aviation, or designee, is authorized to enter into, execute and deliver any and all documents, including, without limitation, agreements, amendments and payment requests, required, or deemed necessary, to accept and secure the allocation of funding made available through the U.S. Department of Transportation Grant Offers on Airport Improvement Project Numbers 3-06-0010-053-2022 and 3-06-0010-054-2022.
2. If the Director of Aviation, or designee, accepts the allocation and funding made available through the enumerated AIP Projects, the County represents and certifies these funds shall only be utilized for lawful airport revenues purposes pursuant to the FAA’s Policy and Procedures Concerning the Use of Airport Revenues.

**WHEREAS**, the County's Department of Aviation submitted to the FAA Project Applications, April 1, 2022, for grants of Federal funds for projects at or associated with the County of Humboldt Airport System;

**WHEREAS**, the FAA has approved projects for the Murray Field Airport (EKA) and Rohnerville Airport (FOT) consisting of the following: Conduct a Wildlife Hazard Assessment; and Conduct an Electrical System Study;

**WHEREAS**, pursuant to and for the purpose of carrying out the Title 49, United States Code (U.S.C.), Chapters 471 and 475; 49 U.S.C. §§ 40101 et seq., and 48103; FAA Reauthorization Act of 2018 (Public Law Number 115-254); the Department of Transportation Appropriations Act, 2021 (Public Law 116-260, Division L); the Consolidated Appropriations Act, 2022 (Public Law 117-103); and the representations contained in the Project Application; and in consideration of: (a) the Sponsor's adoption and ratification of the Grant Assurances attached hereto; (b) the Sponsor's acceptance of this Offer; and (c) the benefits to accrue to the United States and the public from the accomplishment of the Project and compliance with the Grant Assurance and conditions as herein provided; the Federal Aviation Administration has allocated to the County of Humboldt funding that has been made available through the Airport Improvement Program.


