RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING EXECUTION OF COOPERATIVE FIRE PROGRAMS – FIRE PROTECTION REIMBURSEMENT AGREEMENT NO. 1CA05254 WITH THE CALIFORNIA DEPARTMENT OF FORESTRY AND FIRE PROTECTION REGARDING THE PROVISION OF FIRE DISPATCH SERVICES WITHIN HUMBOLDT COUNTY

WHEREAS, pursuant to California Public Resources Code Section 4114, and other provisions of state law, the State of California, by and through the California Department of Forestry and Fire Protection (“CalFIRE”), maintains fire prevention and suppression forces, including, without limitation, equipment, personnel and facilities, necessary to prevent and extinguish forest fires; and

WHEREAS, CalFIRE has offered to provide certain fire dispatch services in support of the local fire protection districts with Humboldt County; and

WHEREAS, the County of Humboldt (“County”), by and through its County Administrative Office, have determined that there is a need for CalFIRE to provide such fire dispatch services within Humboldt County.

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

1. The Humboldt County Administrative Officer, or a designee thereof, is hereby is authorized to execute and deliver, in accordance with any and all applicable local, state and federal laws, regulations and standards, Cooperative Fire Programs – Fire Protection Reimbursement Agreement No. 1CA05254, and any amendments thereto, along with any and all other certifications, agreements and documents required or deemed necessary or appropriate for the County to accept and secure its obligations thereunder.
2. The County hereby certifies and represents that it will accept CalFIRE’s provision of fire dispatch services in a manner consistent, and in compliance, with the terms and conditions set forth in Cooperative Fire Programs – Fire Protection Reimbursement Agreement No. 1CA05254, as well as any and all applicable local, state and federal laws, regulations, standards and contractual requirements.
