**RESOLUTION NAMING A PORTION OF STATE HIGHWAY 101 BETWEEN DRAKE HILL ROAD AND PALMER BOULEVARD IN FORTUNA, CALIFORNIA IN MEMORY OF JAMES (JIM) MOWREY.**

**WHEREAS,** in January 2016, Jim earned his Advanced POST Certificate; and

**WHEREAS,** Jim was transferred to Humboldt County Drug Task Force in April 2016; and

**WHEREAS,** Jim was promoted to Sergeant in October 2018; and

**WHEREAS,** in March 2021 Jim received his POST Supervisory Certificate.

**WHEREAS,** Jim became a Drug Task Force Sergeant in November 2022 where he remained to finish his career; and


**WHEREAS,** his vibrant energy left an indelible mark on everyone he met; and
