**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS IMPLEMENTING PHASE 2 EQUITY INCREASES FOR CERTAIN CLASSIFICATIONS IN THE DESIGNATED MANAGEMENT AND CONFIDENTIAL EMPLOYEES AND ADOPTING THE COMPREHENSIVE COMPENSATION SCHEDULE**

**WHEREAS**, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

**WHEREAS**, on January 4, 2022, the Board of Supervisors adopted Resolution No. 22-19, providing for the implementation of the 2022-2024 Compensation Plan for Designated Management and Confidential Employees; and

**WHEREAS**, the Board of Supervisors intends to amend the 2022-2024 Compensation Plan for Designated Management and Confidential Employees; and

**WHEREAS**, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS:**

1. Approve the implementation of the Phase 2 equity increases effective the pay period following board approval, by assigning the following classifications to the following salary ranges:
  - Assistant Auditor-Controller (class # 0646) from salary range 523 to 543
  - Senior Staff Services Manager (class # 0394) from salary range 494 to 520
  - Staff Services Analyst III (class # 0396) from salary range 482 to 490
  - Staff Services Manager (class # 0395) from salary range 484 to 510
  - Supervising Staff Services Analyst – M/C (class # 0397) from salary range 495 to 500
  - Veterans Service Officer (class # 0672) from salary range 421 to 436
2. Approve the Comprehensive Compensation Schedule and Classification Summary effective the pay period following board approval (Attachment 5).
