리민리민리리리리리리 **PROCLAMATION** of the **Board of Supervisors County of Humboldt** WHEREAS, the theme of the 2016 National Alcohol Awareness Month is "Talk Early, Talk Often: Parents Can Make a Difference in Teen Alcohol Use; and WHEREAS, alcohol is a primary factor in the four leading causes of death for young persons ages 10-21; and WHEREAS, alcohol is the most commonly used addictive substance in the United State and the most used drug for Humboldt County youth; and WHEREAS, young people who begin drinking before age 15 are four times more likely to develop alcohol dependence than those who begin drinking at age 21; and WHEREAS, young people who drink are more likely to be victims of violent crime, to be involved in alcohol-related traffic crashes, and to have serious school-related problems; and WHEREAS, a supportive family environment is associated with lowered rates of alcohol use for adolescents; and WHEREAS, kids who have conversations with their parents and learn about the dangers of alcohol and drug use are 50% less likely to use alcohol and drugs than those who don't have such conversations. WHEREAS, the Humboldt Allies for Substance Abuse Prevention work to reduce harms from alcohol and drugs in Humboldt County, including working with the Eureka Police Department to pass a Social Host Ordinance, where adults who host a party where underage drinking occurs can receive a civil fine; and WHEREAS, Humboldt Allies for Substance Abuse Prevention will support the adoption of social host ordinances in multiple communities throughout Humboldt County; and WHEREAS, the Humboldt County Department of Health and Human Services works to prevent underage drug and alcohol use and create a safe and healthy environment, and to offer services for substance abuse and addiction treatment... NOW, THEREFORE, BE IT RESOLVED, that the Humboldt County Board of Supervisors hereby proclaims April 2016 as Alcohol Awareness Month in Humboldt County, and calls upon all citizens, parents, governmental agencies, public and private institutions, businesses, hospitals, schools and colleges in Humboldt County to support efforts that will provide early education about alcoholism and addiction and increase support for individuals and families coping with alcoholism.
