WHEREAS, Investigator Fulton successfully completed the Police Academy at the College of the Redwoods in 2002 and was hired by Sheriff Gary Philp to the position of Deputy Sheriff I in December of that year; and

WHEREAS, Investigator Fulton was assigned as a Patrol Deputy at the Garberville Station from the date of hire until 2005; and

WHEREAS, Investigator Fulton was assigned to the Sheriff's Special Services Division as a Livestock Deputy/Rural Crimes Investigator from 2005 until 2013; and

WHEREAS, Investigator Fulton was assigned to the Patrol Division in Eureka from January-March 2013; and

WHEREAS, Investigator Fulton was promoted to Rotational Detective in March of 2013; and

WHEREAS, Investigator Fulton was promoted to full time Investigator in June of 2013; and

WHEREAS, Investigator Fulton received extensive training in Search and Rescue; and

WHEREAS, Investigator Fulton has received extensive training with firearms and has been a Range Master since 2004 and is currently a defensive tactics instructor; and

WHEREAS, Investigator Fulton was a member of S.W.A.T. for an extended period of time; and

WHEREAS, Investigator Fulton has been a member of the California Rural Crime Prevention Task Force since 2005; and

WHEREAS, Investigator Fulton has received numerous letters of commendation and appreciation from the public he serves and protects.
