

RESOLUTION OF THE BOARD OF SUPERVISORS COUNTY OF HUMBOLDT

Whereas, Pastor Daniel Price, “Pastor Dan”, graduated from Westmont College in Santa Barbara with a B.A. in Religious Studies in 1974. He then went to Fuller Theological Seminary in Pasadena to gain his Master’s Degree. And in 1991, Pastor Dan received his Ph.D. in Theology from the University of Aberdeen in Scotland; and

Whereas, Pastor Dan was ordained on September 24, 1978 and then began his ministry work as an Associate Pastor at Easton Presbyterian Church in Fresno, California; and

Whereas, Pastor Dan then moved to Scotland for a year at Yoked parish of Fettercairn, Auchenblae, and Glenbervie as an interim Pastor to the small rural parishes; and served St. Columba’s church, Aberdeen, Scotland as Interim Pastor for a year; and then was the Interim Pastor at the Church of Scotland, Dunnottar Parish, Stonehaven; and

Whereas, from 1990 through 1993, Pastor Dan was the Pastor of the International Protestant Church of Zurich, Switzerland; and

Whereas, in 1993 Pastor Dan began his service in Humboldt County as the Senior Pastor at the First Presbyterian Church of Eureka where he has been serving his community for the past 25 years; and

Whereas, Pastor Dan has not only been a dedicated Church leader, he has also been a community servant, a writer, a teacher and a guest lecturer; and

Whereas, when Pastor Dan is not serving his church, he enjoys spending time with his wife, his children and his grandchildren; and

Whereas, Pastor Dan also enjoys hobbies such as surfing, rock climbing, mountaineering, skiing, bicycling, reading, writing and informal debate.

Therefore, Be It Resolved, that the Humboldt County Board of Supervisors, commend Pastor Dan on his 25 years of service at the First Presbyterian Church of Eureka, and wishes him well on his retirement.
