DISCUSSION:

On February 09, 2016, your Board approved the FY 2016-17 Budget & Fee Schedule Calendar. As stated in the calendar, on June 7, 2016, the County Administrative Office will present to the Board of Supervisors the proposed Humboldt County budget for FY 2016-17. In addition, the calendar also stated the public hearing was to be held on June 20th. The public hearing provides an occasion for public input into the budget. The public hearing also allows for public comment as well as staff input, and provides an opportunity for your Board to provide direction to staff prior to budget adoption, scheduled for June 28.

Recommended budget documents for Fiscal Year 2016-17 are available to members of the public for review. The Humboldt County Board of Supervisors will conduct a public hearing on the recommended budget on Monday, June 20, 2016 at 1:30 p.m. and again at 6:00 p.m., or as soon thereafter as the matter may be heard in the Board of Supervisors Chambers, Courthouse, First Floor, Eureka, California, the Humboldt County Board of Supervisors. The public hearing on the recommended budget will allow any member of the public to appear and be heard at the hearing.
