**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING THE  
APPLICATION FOR AND ACCEPTANCE OF PROBATION SPECIALIZED UNITS (PU) GRANT FUNDS**

**WHEREAS**, the Probation Specialized Units (PU) Program, administered by the California Governor's Office of Emergency Services (Cal OES), provides funding to support specialized units within probation departments in California;

**WHEREAS**, the purpose of the PU Program is to provide focused supervision to probationers of crimes involving domestic violence, sexual assault, dating violence, and/or stalking, through a reduced caseload, according to the California Governor's Office of Emergency Services;

**WHEREAS**, the Humboldt County Probation Department is an eligible applicant for the PU Program as a California County Probation Department;

**WHEREAS**, the Humboldt County Probation Department desires to apply for a PU grant to enhance its probation services and improve outcomes for the probationer population of its jurisdiction;

**WHEREAS**, the Humboldt County Probation Department acknowledges and understands the terms and conditions associated with the PU Grant program, including reporting requirements and the utilization of evidence-based practices.

**NOW, THEREFORE BE IT RESOLVED** by the Humboldt County Board of Supervisors as follows:

1. The Humboldt County Board of Supervisors authorizes the submittal of a grant application to Cal OES for the Probation Specialized Units (PU) Program.
2. The Chief Probation Officer is hereby authorized to sign and submit the grant application and any related documents, including amendments, required for participation in the PU Program.
3. The Humboldt County Probation Department agrees to accept any Probation Specialized Units (PU) Grant funding awarded by Cal OES, in an amount up to One Hundred and Twenty-Five Thousand Dollars.

4. The Humboldt County Probation Department commits to fulfilling all requirements of the PU Program, including providing any required matching funds and adhering to all terms and conditions outlined in the grant agreement.
5. This Resolution shall be effective upon its adoption by the Humboldt County Board of Supervisors.
