DETERMINATION OF PUBLIC CONVENIENCE FOR ISSUANCE OF A TYPE 20 ALCOHOLIC BEVERAGE LICENSE TO CAMP TRINIDAD LLC AT 3443 PATRICK'S POINT DRIVE, TRINIDAD, CALIFORNIA

WHEREAS, Camp Trinidad LLC, operator of the facility located at 3443 Patrick's Point Drive, Trinidad, California has applied to the Department of Alcoholic Beverage Control for a Type 20 alcoholic beverage license; and ; and

WHEREAS, a Type 20 alcoholic beverage license allows both beer and wine to be sold and consumed as an **off premises** license; and

WHEREAS, this location is in an area where there is an over-concentration of alcoholic beverage licenses and the decision to issue or not issue this license will be decided by the Department of Alcohol Beverage Control on its own unless the Board of Supervisors makes a determination as to whether the issuance of the license would serve as a public convenience or necessity; and

WHEREAS, the Humboldt County Board of Supervisors reviewed and consider this request at its regular meeting on September 9, 2025.

NOW, THEREFORE, IT IS HEREBY RESOLVED AND DETERMINED by the Board of Supervisors declares that the issuance of a Type 20 alcoholic beverage license to Camp Trinidad LLC of 3443 Patrick's Point Drive, Trinidad, California, is a benefit to the community and serves as a public convenience.
