RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS IMPLEMENTING COST OF LIVING ADJUSTMENTS SCHEDULED FOR THE FIRST FULL PAY PERIOD IN JANUARY 2024 FOR ELECTED AND APPOINTED DEPARTMENT HEADS (UNITS 10 AND 11) EARLY AND ADOPTING THE COMPREHENSIVE COMPENSATION SCHEDULE AND CLASSIFICATION SUMMARY.

WHEREAS, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

WHEREAS, on October 25, 2022, the Board of Supervisors adopted Resolution No. 22-132, providing for the implementation of the 2022-2024 Compensation Plan for Elected and Appointed Department Heads (Units 10 and 11); and

WHEREAS, the Board of Supervisors desires to implement the three (3) percent COLAs scheduled for the first full pay period in January 2024, early effective December 24, 2023, for all classifications in Elected and Appointed Department Heads (Units 10 and 11); and

WHEREAS, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS:

1. The three (3) percent COLAs scheduled for the first full pay period in January 2024, shall be implemented early effective the pay period beginning December 24, 2023, for all classifications in Elected and Appointed Department Heads (Units 10 and 11).
2. Resolution No. _____ is approved amending the Compensation Plan between the County of Humboldt and Elected and Appointed Department Heads (Units 10 and 11).
3. The December 24, 2023, Comprehensive Compensation Schedule and Classification Summary is adopted.
