**GOVERNING BODY RESOLUTION FOR U.S. DEPARTMENT OF JUSTICE COMMUNITY ORIENTED
POLICING SERVICES FY2026 SCHOOL VIOLENCE PREVENTION PROGRAM**

WHEREAS, the Humboldt County Sheriff's Office desires to participate in the Community Oriented Policing Services FY2026 School Violence Prevention Program administered by the United States Department of Justice (hereafter referred to as DOJ).

NOW, THEREFORE, IT IS HEREBY PROCLAIMED that the Humboldt Board of Supervisors hereby:

1. Approves receiving grant funding from the Community Oriented Policing Services of the DOJ.
2. Authorizes the County Administrative Officer, Sheriff, and Sheriff's Deputy Director of Financial and Support Services to submit this governing body resolution for the Community Oriented Policing Services FY2026 School Violence Prevention Program, accept grant funds, and sign any required documents required for participation in the grant program (provided all contractual documents are reviewed and approved by County Risk Management and County Counsel in advance of signing).
3. Appoints the Sheriff, Undersheriff, or Deputy Director of Sheriff's Financial and Support Services as agent to conduct all negotiations, execute and submit all documents including, but not limited to all necessary applications, strategic plans, letters of agreement, contracts, amendments, and reimbursement claims which may be necessary for obtaining federal financial assistance provided by the DOJ for the Community Oriented Policing Services FY2026 School Violence Prevention Program funding opportunity (provided all contractual documents are reviewed and approved by County Risk Management and County Counsel in advance of signing).

IT IS FURTHER PROCLAIMED AND ORDERED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

IT IS FURTHER PROCLAIMED AND ORDERED that the County of Humboldt agrees to abide by the statutes and regulations governing the federal Formula Grants Program as well as the terms and conditions of the Grant Amendment set forth by the DOJ.
