**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS
AMENDING RESOLUTION No. 22-03 (Compensation Plan for Management &
Confidential Employees)**

WHEREAS, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

WHEREAS, on January 4, 2022, the Board of Supervisors adopted Resolution No. 22-03, providing for the implementation of the January 1, 2022 – December 31, 2024 Compensation Plan for Management & Confidential Employees; and

WHEREAS, the Board of Supervisors desires to amend Resolution No. 22-03, providing for the implementation of the January 1, 2022 – December 31, 2024 Compensation Plan for Management & Confidential Employees to increase the salary for County Surveyor; and

WHEREAS, California Employees Retirement System (CalPERS) does require all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors:

1. Approves the amendment to Resolution No. 22-03, adjusting the January 1, 2022 – December 31, 2024 Compensation Plan for Management & Confidential Employees to adopt the revised salary range for County Surveyor (class 0207, salary range 610, unit 08) into the classification plan; and
2. Adopts the amended Comprehensive Compensation Schedule and Classification Summary (Attachment 2 to the report of this same date) with the increase in salary for County Surveyor, effective April 17, 2022.
