RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING ACCEPTANCE OF GRANT FUNDING MADE AVAILABLE BY THE CALIFORNIA DEPARTMENT OF INSURANCE THROUGH THE WORKERS' COMPENSATION INSURANCE FRAUD PROGRAM

WHEREAS, the Humboldt County District Attorney's Office has partnered with both the Del Norte and Trinity County District Attorney's Offices for the purpose of developing and operating a regional Insurance Fraud Unit; and

WHEREAS, the regional Insurance Fraud Unit is responsible for investigating and prosecuting workers' compensation fraud, and providing community outreach regarding identification and reporting of insurance fraud in all three regional areas; and

WHEREAS, on April 22, 2019, the County of Humboldt ("County"), by and through the Humboldt County District Attorney's Office, submitted an application for grant funding made available by the California Department of Insurance through the Worker's Compensation Insurance Fraud Program in order to continue operating the regional Insurance Fraud Unit during fiscal year 2019-2020; and

WHEREAS, on July 2, 2019, the California Department of Insurance awarded the Humboldt County District Attorney's Office grant funding through the Workers' Compensation Insurance Fraud Program in the amount of Two Hundred Twenty-Three Thousand Four Hundred Ninety-Four Dollars (\$223,494.00) to allow for the continued operation of the regional Insurance Fraud Unit during fiscal year 2019-2020; and

WHEREAS, the Humboldt County District Attorney's Office, will reapply for grant funding made available by the California Department of Insurance through the Worker's Compensation Insurance Fraud Program in order to continue operating the regional Insurance Fraud Unit during fiscal year 2020-2021.

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The County's submission of an application for grant funding made available by the California Department of Insurance through the Worker's Compensation Insurance Fraud Program is hereby ratified.
- 2. The Humboldt County District Attorney, or a designee thereof, is hereby authorized to enter into, execute and deliver a State of California Standard Agreement ("State Standard Agreement") for the amount of Two Hundred Twenty-Three Thousand Four Hundred Ninety-Four Dollars (\$223,494.00), and any future amendments thereto, along with any and all other documents required or deemed necessary or appropriate to secure, accept and reapply for the grant funding awarded by the California Department of Insurance through the Workers' Compensation Insurance Fraud Program.
- 3. The County shall not use any of the grant funds received through the Worker's Compensation Insurance Fraud Program to supplant expenditures controlled thereby.
- 4. It is agreed that any liability arising out of the performance of the Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the Humboldt County District Attorney's
