The County of Humboldt through its County Administrative Office - Management and Budget Team, is issuing this Request for Proposals ("RFP") for the lease of a building(s) for the co-location of multiple county departments for a one-stop permitting services location in the Eureka area. Specifications are for approximately 40,000 square feet (53,000 square feet with Additive Option 1) of a build-to-suit building or a modified existing building. The desired occupancy date is within 180 days for a modified existing building proposal and 720 days for build-to-suit proposals.

If you wish to submit a proposal, submit five (5) hard copies and one (1) electronic on USB of all requested information in a sealed envelope. A return address and the words "Proposal: One-Stop Permitting Services Location" must be printed on the outside face of the envelope.
