WHEREAS, in 1997, Kevin Miller was hired as a Deputy Sheriff II with the Humboldt County Sheriff's Office; and

WHEREAS, in 1998, Kevin Miller was assigned to the HCSO Special Enforcement Team (SET, but later changed to SWAT); and

WHEREAS, in 2001, Kevin Miller was assigned to the HCSO Drug Enforcement Unit (DEU); and

WHEREAS, in 2003, Kevin Miller was promoted to the rank of Sergeant, and through 2014, he served in this capacity at the Hoopa Sub Station, McKinleyville Sub Station, and the Main Station in Eureka; and

WHEREAS, in 2014, Kevin Miller was promoted to the rank of Lieutenant; and

WHEREAS, in 2015, Kevin Miller was appointed to be the Assistant Commander on the SWAT Team; and
