5. IN WITH THE LETTER OF VIOLATION AND PICTURES, IS THERE NOT COPIES OF ANY AND ALL COMPLAINT/S AND REFERRAL/S?
6. IF THERE AREN'T ENOUGH AND/OR ANY FACTS FOR A VIOLATION LETTER, WHEN SHOULD A LETTER CLOSING THE FILE BE SENT STATING THAT TO THE OWNER?
7. ONCE A INSPECTION HAS OCCURRED AND THE PARCEL IS NO LONGER IN VIOLATION OF COUNTY CODE/S WHEN DOES THE FILE CLOSE?
8. WHY ISN'T THERE AN OFFICIAL LETTER SENT TO THE OWNER STATING THAT THE FILE IS OFFICIAL CLOSED?
9. IF THE PARCEL PASSED AND NO LETTER IS SENT WHEN IS THE FILE CLOSED?
10. CAN THERE BE MORE VISITS TO THE PARCEL TO CHECK ON IT AFTER PASSING THE INSPECTION?

11. THE COUNTY CAN TAKE A PERSON INTO THREE DIFFERENT LEGAL COURTS. WHY DOES THE COUNTY GO TO CRIMINAL COURT INSTEAD, FOR COUNTY CODE VIOLATIONS?
12. WHY IS A LOW-INCOME PERSON RECEIVE LEGAL REPRESENTATION IN ONLY ONE (SAME COUNTY - SAME LOW INCOME PERSON), WHY NOT IN THE OTHER TWO COURTS?
